

Privacy Policy

1. Overview

This site is an independent, neutral third-party review platform. We do not sell, manufacture, or endorse any of the products reviewed on this site. Our goal is to provide a space for honest, unsponsored reviews from real users.

This Privacy Policy explains what personal data we collect when you submit a review, why we collect it, how long we retain it, and what rights you have over your data.

This site is operated from the United States. By using this site, you acknowledge that your data will be processed in accordance with this policy.

2. What We Collect

When you submit a review, we collect the following information:

Display Name

You provide a display name or Discord username to be shown publicly alongside your review. This is the only piece of information that is visible to other users.

IP Address

Your IP address is automatically recorded at the time of submission. It is used solely for spam and abuse prevention — specifically, to detect and filter fraudulent or duplicate submissions.

We do not display your IP address publicly, share it with third parties, or use it for any purpose beyond initial spam filtering. IP addresses are deleted from our systems within 30 days of submission.

3. Legal Basis for Processing

For visitors from the European Union or European Economic Area, we process your data under the following legal bases under the GDPR:

- Display name: Processing is necessary to fulfill the core purpose of the service — publishing your review under an identity you have chosen.
- IP address: Processing is based on our legitimate interest in preventing spam, abuse, and fraudulent submissions. We apply data minimization by deleting IP addresses promptly once their purpose has been served.

4. Data Retention

We retain your data for the following periods:

- Display name: Retained as part of your review for as long as the review remains published on the site.
- IP address: Deleted within 30 days of submission.

If you request deletion of your review (see Section 6), your display name will also be removed.

5. Third-Party Services

We do not use third-party analytics, advertising networks, or tracking services. We do not sell, rent, or share your personal data with any third parties.

Note: Standard web hosting and server infrastructure will process connection data (including IP addresses) as a technical necessity of operating any website. This is governed by our hosting provider's own privacy practices.

6. Your Rights

You have the following rights regarding your personal data:

- Right of access: You may request a copy of the data we hold about you.
- Right to rectification: You may request that inaccurate data be corrected.
- Right to erasure: You may request that your review and associated data be deleted.
- Right to restriction: You may request that we limit how we process your data.
- Right to object: You may object to processing based on legitimate interests.

If you are located in the EU/EEA, you also have the right to lodge a complaint with your local data protection authority.
